709645 Duble, 81 Conewago Dr. Requested \$50.00 penalty waiver Chris Stroup made a **motion** to waive the \$50.00 penalty on account 709645 incurred in the May 2017 sewer billing. Lynn Toft made the second. The **motion carried** with a vote of 4-1 with Chairman LeGore casting the opposing vote.

820223 Fox, 76 Seneca Dr. Requested an adjustment for excess water consumption, it was an outside leak which went into her yard.

Christopher Stroup made a **motion** to make an adjustment to account 820233 for the excess water consumption. Francis Tananis made the second.

Chris Stroup made a **motion** to deny the request to credit 820626 for the leaking toilet.

Francis Tananis made the second. **Request Denied: Vote 5-0** 

Mr. Stroup suggested a payment plan and the board was in agreement to allow a payment plan for the excessive sewer bill.

824533 Paulin, 19 Dickinson Dr. Requested adjustment-outside leak/water went into yard. Christopher Stroup made a motion to approve an adjustment to account 824533 for the excess water consumption. Lynn Toft made the second.

## 6. Report from Engineer, Michael Mehaffey, P.E. of Gannett Fleming

Michael Mehaffey provided the members with a report of current Authority Engineering Activities. The report will be included as part of official minutes. The following items were discussed:

## • 2016-2017 Sanitary Sewer Rehabilitation Project

Mr. Mehaffey explained that the current I & I project has been completed and Gannett will do the final inspections this month. Mr. Mehaffey provided the members with a map and explained the next phase which will be within Sewer Sheds 2 and 7. The next phase has been put out for bids.

## • Chapel View Sanitary Sewer Easement:

A resident on Friendly Drive planted trees in the sewer easement.

After discussion, the board authorized Solicitor McQuaide to research the issue and send correspondence to the homeowners to have the homeowners remove the trees.

# • J.A. Myers , 170 Ram Dr. Building Addition

The review of July 11, 2017 directed the applicant to have the sewer lines air tested.

# • J.A. Myers Linden Commons

Mr. Mehaffey advised that all technical comments regarding the plan have been addressed.

## • Trone Rentals Property on Wetzel Drive:

Mr. Mehaffey reported that the EDU Assessment is 13 EDU's and the ERU amount can be increased in the future if property's use changes.

## Precision Cut-Proposed Warehouse-request for sewer capacity

Mr. Mehaffey stated that Gannett Fleming acknowledged that sewer capacity is available.
