PRETREATMENT ORDINANCE**

**ORDINANCE NO. 2020-A**

---

**AN ORDINANCE ADOPTED TO REQUIRE PRETREATMENT OF INDUSTRIAL WASTEWATERS INTO THE TOWNSHIP SEWAGE SYSTEM AND THE HANOVER BOROUGH SEWAGE TREATMENT SYSTEM AND TREATMENT PLANT; TO AMEND THE ADOPTED STANDARDS PROMULGATED BY HANOVER BOROUGH AS THE OWNER AND OPERATOR OF THE HANOVER AREA REGIONAL WASTEWATER TREATMENT PLANT, AND EMPOWERING THE BOROUGH OF HANOVER TO ENFORCE THIS ORDINANCE AND THE AMENDED STANDARDS ADOPTED BY THE BOROUGH OF HANOVER IN ITS PRETREATMENT ORDINANCE KNOWN AS ORDINANCE NO. 2293.**

**WHEREAS**, sewage produced in Conewago Township, Adams County, Pennsylvania, is currently treated at the sewage treatment plant owned and operated by the Borough of Hanover, pursuant to an inter-municipal agreement for such treatment between the Borough of Hanover of York County, Pennsylvania, and the Borough of McSherrystown and the Township of Conewago of Adams County, Pennsylvania; and

**WHEREAS**, the provisions of said inter-municipal agreement and the best interest of the Township of Conewago require that the Pretreatment Ordinance of Conewago Township, Adams County, Pennsylvania, contain the same provisions contained in the Pretreatment Ordinance of the Borough of Hanover; and

**WHEREAS**, the Pretreatment Ordinance of the Borough of Hanover must be amended periodically to reflect changes in sewage treatment requirements of the U.S. Environmental Protection Agency and the Pennsylvania Department of Environmental Protection, their successor or assigns; and

**WHEREAS**, the need and desire of the Township of Conewago, Adams County, Pennsylvania, is to keep the provisions of its Pretreatment Ordinance matched to the provisions of the Pretreatment Ordinance of the Borough of Hanover, as it is amended from time to time; and

**WHEREAS**, the further need and desire of the Township of Conewago, Adams County, Pennsylvania, is to empower the Borough of Hanover, which is better situated to monitor and discover violations of the Borough's Pretreatment Ordinance, to enforce the provisions of the Pretreatment Ordinance in conjunction with the officials of the Township of Conewago, the Commonwealth of Pennsylvania and agencies of the federal government against violators located within the Township of Conewago, hereafter referred to as the Township.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED**, and it is hereby adopted, enacted and ordained by the Board of Supervisors of the Township of Conewago, Adams County, Pennsylvania as follows:

**SECTION 1. Adoption of Hanover Ordinance Provisions**

- A.) All provisions of Ordinance No. 1977 of the Borough of Hanover, York County, Pennsylvania, as amended by Ordinance No. 2173, be amended to incorporate the provisions established within the Borough of Hanover Ordinance 2293, which was dated, enacted and ordained by the Borough of Hanover officials on December 23, 2019.
  
- B.) All provisions of Ordinance No. 1977, Ordinance No. 2173, and Ordinance No. 2293 of the Borough of Hanover, York County, Pennsylvania, as amended to the date of this Ordinance, are hereby incorporated herein and this Ordinance, including the content of the incorporated Ordinances, is adopted as an Ordinance of this Township and is expressly declared to be applicable to and enforceable against all entities and individuals located, doing business or residing in Conewago Township of Adams County, Pennsylvania.

**SECTION 2. Enforcement Authority**

Conewago Township of Adams County, Pennsylvania hereby delegates to the Borough of Hanover power and authority to enforce the provisions of this Ordinance together with officials of Conewago Township and other state and federal bodies having jurisdiction over this matter and the Borough of Hanover is hereby expressly designated as the authorized agent of Conewago Township, Adams County, Pennsylvania, for purposes of enforcement of this Ordinance.

**SECTION 3. Available Copy of Hanover Ordinance**

A copy of the full text of Ordinance No. 2293 of the Borough of Hanover as amended from time to time, shall be available for inspection at the Hanover Municipal Building located at 44 Frederick Street, Hanover, Pennsylvania, as well as the Conewago Township Municipal Office located at 541 Oxford Avenue, Hanover, Pennsylvania.

**SECTION 4. Repeal of Prior Ordinance**

The Township Ordinance provision inconsistent with the provisions of this Ordinance including the provisions of the Hanover Borough Ordinance reference above are hereby deemed null and void. Any Township Ordinance or Ordinance provisions not inconsistent herewith shall not be effected hereby.

**SECTION 5. Construction and Severability**

If any of the provisions, sections, clauses or parts of this Ordinance or the application thereof shall, for any reason, be held invalid, such invalidity shall not affect or impair any of the remainder of this Ordinance, it being the intention of Conewago Township of Adams County, Pennsylvania, that such remainder shall be and remain in full force and effort.

**SECTION 6. Codification.**

This Ordinance shall be codified in the Codified Ordinances of Conewago Township, Adams County, Pennsylvania, and shall amend such codification as necessary to codify this Ordinance.

**SECTION 7. Effective Date**

This Ordinance shall become effective five (5) days following its enactment as provided.
